2024 MPHA AWARDS INFORMATION

The Mississippi Public Health Association has a long history of recognition of outstanding public health work in Mississippi. There are many deserving and long serving professionals we would like to recognize as part of our Public Health Conference. Please assist us in this as we seek nominations in four award categories:

1. **Prestige Awards** - The highest honors awarded for four specific achievements and lifetime of work accomplishment in public health.
2. **Awards for Notable Public Health Work** - These awards acknowledge work that is going on in health equity; public health service and outreach (President's Award), and individuals new to the fields of public health who have demonstrated exceptional leadership (Rising Star Award)
3. **Longevity Awards** - Recognizes members who have 20, 25, 30, 35, 40+ years of public health service.
4. **Section Awards** - Our sections recognize outstanding service and professionalism in their respective areas of expertise.

DEADLINES

In order to plan and adequately prepare, all award nominations must be submitted by the deadline listed in each section of this application packet.

MPHA PRESTIGE AWARDS

MPHA is proud to recognize outstanding contributions through our most prestigious awards in recognition of five outstanding representatives of public health in Mississippi.

Felix J. Underwood Award: Given to individuals who share concern with Dr. Underwood – “the father of public health in Mississippi” – for protecting the health of Mississippians.

Alton B. Cobb Lifetime Achievement Award: Given to individuals who exemplify the service standards set by Dr. Alton Cobb.

Jon “Vic” Bailey Award: Given to an individual who has performed outstanding service to his or her community or to an individual in the community during the preceding 12 months.

Larry H. Rouse MPHA Outstanding Member Award: Given to an individual member of MPHA for outstanding contributions, leadership, and achievements in service to MPHA.

MPHA Community Service Award: This Award was established in 2018 to recognize outstanding contributions to community (ies) by an individual, organization, or community who provided significant impact on the health and well-being of the citizens being represented.

NOTE: Except for the Community Service Award, individuals nominated must have been active MPHA members for at least five consecutive years to receive the award.

- Nominations are made from members, sections, and other public health professionals from across the state.
- Nominations are accepted by completion and submission of Prestige Nomination Form and supporting documents.
- Winners are selected by vote of the MPHA Board of Directors.

HEALTH EQUITY AWARD

The Health Equity Award recognizes individuals who are making health equity a reality in their communities. The award highlights innovative approaches to equity and shines a light on leaders across the state who demonstrates success in changing systems that impact health outcomes in one or more of the following areas: access to quality care, education, employment, income, community environment, housing, and public safety. These efforts overall improve outcomes for groups most disproportionately affected by health disparities.

CRITERIA:

1. Demonstrate efforts that advance the mission of the Mississippi Public Health Association Health and Racial Equity platform.
2. Demonstrate success in changing systems that impact health outcomes in one or more of the following areas: access to quality care, education, employment, income, community environment, housing, and public safety.
3. Targeted efforts that improve outcomes for groups most affected by health disparities.
4. Successful implementation of a systems change approach to reduce health disparities within the past two years.
5. Ongoing community engagement.

PROCESS:

The MPHA Health Equity Award seeks to recognize individuals or organizations who have successfully implemented systems change approaches to reduce health disparities within the past two years related to one or more of the following areas: access to quality care, education, employment, income, community environment, housing, and public safety.

PRESIDENT’S CIRCLE AND RISING STAR AWARDS

The Mississippi Public Health Association has two additional awards that are decided and awarded by either the President of MPHA or the Board of Directors. The two awards are the President’s Circle Awards and the Rising Star Awards and were established in 2019. The descriptions of the awards are listed below.

For the first time in 2024, the MPHA Board of Directors are opening the nominations for these awards to the membership. If you have a nomination to share with the Board of Directors for their consideration, the information must be submitted no **later than 5:00pm September 9, 2024**. President’s Circle Award

The President’s Circle Award may be given for outstanding teaching, research, and/or service/outreach in public health and in recognition of contributions to the field in Mississippi’s universities or colleges, state agencies, community-based organizations (non-profits), faith-based organizations, businesses, or other entities. Established in 2019, the President’s Circle Award recipients are presented by the President to the MPHA Board of Directors with acknowledgement of their contributions to public health. President’s Circle Awards may be presented throughout the year or at the annual conference.

Rising Star Award

The Public Health Rising Star Awards, created in 2019, recognize the accomplishments of individuals working in the profession for 7 years or less, who have demonstrated exceptional leadership, innovation, and commitment. The recipients of these awards are emerging leaders whose body of work demonstrates ongoing exceptional growth and high potential for future impact in public health. Individuals nominated for this award are poised to make significant contributions to the advancement of health, knowledge, and practice in the public health field.

LONGEVITY AWARDS

If you have been working in the public health field for 20, 25, 30, 35, or 40+ years of service by the end of this calendar year, we would like to recognize you for a 2024 MPHA Longevity Award!

CRITERIA

- Longevity Awards are based on five-year increments beginning with 20 years. The award is based on meeting the five-year increment during the current calendar year. (example: 20 years of service by the end of December 2024)
- **It is the employees/members responsibility to apply for this award, not your supervisor or organization.**
- **MPHA Membership is required to be eligible for this award.** (MPHA membership begins January 1 of each year). If there is a question regarding your membership status, email execdir@mspha.org)
- Longevity Awards will be presented at the MPHA Annual Public Health Conference. Although attendance is not required to receive the award, conference registration is required if you plan to receive the award in-person.

PROCESS

1. Complete the Longevity Awards Information Form and return to MPHA Awards Chair no later than **11:59 p.m. on September 20, 2024.**
2. MPHA will verify and acknowledge you meet the service longevity criteria.
3. Ensure your MPHA Membership is current.
4. You will be asked to submit a picture for the ceremony.
